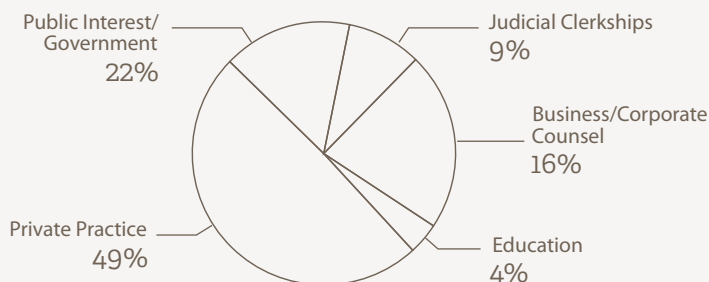

Of the 223 graduates known to be seeking employment, 205 (91.9%) were successful within ten months of graduation.

Professors in Practice

Practice area specific panel discussions with professors about their practices prior to teaching.

Career Night

An evening of career and practice area exploration allowing students to connect with attorneys grouped by practice area.

Drop-In Resume Clinics

Multiple opportunities in the fall and spring semesters to have your resume reviewed to ensure your application materials make the best possible impression.

Attorney-in-Residence

Practicing attorneys present their career paths, answer questions over lunch, and serve as career counselors in a series of one-on-one sessions with students.

Annual Chili Dinner for Public Interest Mentors and Mentees

A fun and informal opportunity for public interest mentors and mentees to interact with practicing attorneys.

1L Summer Job Information Fair

A "career fair" where second- and third-year students speak to first-year students about their summer employment experiences and offer advice on how to find a summer job.

Mock Interview Program

UNC School of Law graduates and practicing attorneys offer mock interviews to first-year students. A perfect "tune-up" of your interview skills prior to the start of the spring interview season.

Public Interest Retreat

A day-long symposium for students pursuing careers with public interest organizations and government agencies.

Employer Reception for 1Ls

This counterpart to Career Night provides first-year students an opportunity to connect with employers who participate in the Fall and Spring on-campus interview programs.

Etiquette Dinner for 1Ls

A business meal is often part of the interviewing process. This evening is designed to remind you of the rules of etiquette and teach you how to comport yourself at networking receptions.

How I Found My Job After Graduation

Recent graduates return for a panel discussion on the job search after graduation. A great opportunity for 3Ls to gather advice on how to structure their search for post-graduation employment.

Professional Development Boot Camp

Whether you plan to work with a firm, non-profit organization, or as a solo practitioner, you will learn how to successfully navigate today's legal profession. Topics include Ethics and Client Confidentiality, Succeeding in a Multi-Generational Workplace, and The Business of the Law.
